General Provisions

A. Introduction

- a. The city of New Town Kolkata has been selected to be developed into a smart city in the Smart Cities Mission launched by the Ministry of Housing and Urban Affairs (MoHUA). The Client is the special purpose vehicle incorporated to implement the Smart Cities Mission in New Town Kolkata in accordance with the Smart City Proposals. The Smart City Plan envisage to make New Town Kolkata a sustainable eco-city where citizen may use bicycles as one of the non-motorized form of transport. In order to facilitate bicycle and other non motorised vehicles as a mode of transport in the city, it is intended to implement a Public Bicycle and e bike Sharing project through selection of an operational partner (in the form of an "Agency") for New Town Kolkata. Therefore, the Client intends to invite bids for Selection of Agency for implementation of Public Bicycle Sharing System with manual as well as electric bicycles in New Town Kolkata, as described in general in this Request for Proposal document. The Bidder is required to comply with the provisions of the RFP for the bidding process and implementation of overall project.
- b. The client intends to have a fleet of 250 vehicle units serving the people of the town. Each such Vehicle Unit shall consist of one manual bicycle and one battery operated (with or without paddle) bicycle. This Vehicle Unit will be the basic unit for all calculation purpose in the bid documents.
- c. The Client has adopted a two stage bid process for selection of the successful Bidder. Bidders who are eligible in accordance with Clauses 2 of the RFP are invited to submit their Proposals for providing the required Services, which will consist of two parts: (a) Technical Proposal and (b) Financial Proposal, each in the formats specified in Section 2 and 3.
- d. The evaluation of the Proposals will be carried out in two sub-stages:
- e. The first sub-stage will involve qualification of the Bidders based on evaluation of their Qualification Documents to determine compliance with the Eligibility Criteria. Only those Bidders who are found to meet the Eligibility Criteria will be qualified for the next sub-stage.
- f. Post technical evaluation bidders in the, will become eligible for the second stage of Financial Evaluation.
- g. The least cost bidder among the technically qualified bidders as at f above will be considered for being selected as the agency for the

implementation and operation of the app based bicycle and e bicycle sharing system in New Town, Kolkata subject to fulfilment of all terms and conditions.

- h. The Bidders should familiarize themselves with the local conditions and take them into account in preparing their Proposals. Prospective Bidders are requested to attend the pre-bid meeting, which will be held on the date specified in the RFP, during which the Bidders will be free to seek clarifications and make suggestions to the Client on the scope of the Services or otherwise in connection with the RFP. Attending any such pre-bid meeting is optional and at the Bidders' expense.
- i. Bidders shall bear all costs associated with the preparation and submission of their proposals, and their participation in the Selection process, and presentation including but not limited to postage, delivery fees, expenses associated with any demonstrations or presentations which may be required by Client or any other costs incurred in connection with or relating to its Proposal. The Client is not bound to accept any Proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability towards the Bidders.

B. Eligibility

A company incorporated under the Companies Act 1956 or the (Indian) Companies Act, 2013 or an equivalent law outside India or a firm or limited liability partnership registered in India or in any other jurisdiction, which meets the Eligibility Criteria shall be eligible to submit a Proposal, OR

An international company that is incorporated in other countries, provided such company submit an undertaking to set up an entity in India as per the statutory laws including Companies Act, 2013 before signing of the agreement with the Client.

C. Acknowledgement by Bidder

- a. It shall be deemed that by submitting the Proposal, the Bidder has:
 - i. made a complete and careful examination of the RFP and any other information provided by the Client under this RFP;
 - ii. accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Client;
 - iii. Satisfied itself about all things, matters and information, necessary and required for submitting an informed Proposal, and performing the Services in accordance with the Contract and this RFP.
 - iv. Acknowledged and agreed that inadequacy, lack of completeness or incorrectness of information provided in this RFP or ignorance of any matter shall not be a basis for any claim for compensation, damages, extension of time for performance of its obligations or loss of profits or revenue from the Client, or a ground for termination of the Contract; and
 - v. Agreed to be bound by the undertakings provided by it under and in terms of this RFP and the Contract.

- vi. acknowledged that The Client and/ or its advisors/ Consultants shall not be liable for any omission, mistake or error on the part of the Bidder in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to this RFP or the Selection Process, including any error or mistake therein or in any information or data given by the Client and/ or its Consultant.

The Bidding Documents

A. Clarification and Amendment of the RFP

- a. Any queries or requests for additional information in relation to the bid documents should be submitted in writing or by fax and email. The queries submitted sent via email should be in excel sheet format only, along with name and details of the organisation submitting the queries. The envelope or communication must clearly bear the following subject line – **"Selection of Agency to Design , Procure, Install, Operate and Maintain Public Bicycle Sharing System in New Town Kolkata"** and sent to the address/number/e-mail address as indicated in the RFP. Such queries must reach the tender inviting authority at least ten days before the last date of submission of the proposal.
- b. The Bidder may substitute, modify or withdraw its Proposal at any time prior to the Proposal Due Date. No Proposal shall be substituted, withdrawn or modified after the time specified for bid submission date in the RFP

Preparation of Proposals

A. Cost of Preparation of Proposal

- a. Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed in the website <http://wbtender.gov.in>. Tender documents may be downloaded from the website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated.
- b. The Bidder shall bear all costs associated with the preparation and submission of its Proposal, and the Client shall not be responsible or liable for those costs, regardless of the conduct or outcome of the selection process. The Client is not bound to accept any Proposal, and reserves the right to annul the selection process at any time prior to award of the Contract, without assigning any reason and without incurring any liability to the Bidder.

B. Language

The Proposal, as well as all correspondence and documents relating to the Proposal exchanged between the Bidder and the Client shall be in written and in English only.

C. Proposal Validity

Each Proposal must remain valid for the period of 180 days.

During the Proposal validity period, the Bidder shall abide by its original Proposal without any change.

D. Extension of Validity Period

The Client may request, in writing, all Bidders who submitted Proposals prior to the Proposal Due Date to extend the Proposals' validity

If the Bidder agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal

The Bidder has the right to refuse to extend the validity of its Proposal in which case such Proposal will not be further evaluated, and the EMD of such Bidder will be returned in the manner set out in this RFP.

In the event a Bidder agrees to extend the validity of its Proposal, the validity of the EMD submitted by such Bidder along with the Proposal (where the EMD is submitted in the form of a bank guarantee) will also be extended for an equivalent period.

E. Qualification Documents and Technical Proposal Format

The Qualification Documents and Technical Proposal are un-priced proposals and shall not include any financial information.

The Qualification Documents submitted by a Bidder shall comprise the following:

- i. The Qualification Documents Proposal Submission Form in the forms attached at Annexure 2 and Annexure 6;
- ii. Details of the Bidder in form set out at Annexure 3;
- iii. A power of attorney for signing the Proposal in the format set out in Annexure 4;
- iv. Financial qualification of the Bidder in the format set out in Annexure 5 along with self-attested (by the constituted attorney) copies of duly audited financial statements for the financial years being considered for the purposes of evaluation of the Bidder's financial capacity (2017-18,2018-19).
- v. Affidavit certifying that the Bidder is not blacklisted in the format set out in Annexure 7;
- vi. Copy of GST registration in India; and
- vii. Duly certified copy of the Bidder's certificate of incorporation/certificate of registration issued under applicable laws in India

F. Financial Support

The operators will be provided with grant subsidy support for deployment of bicycles and during operation stage, as per the terms and conditions laid down in this section.

Subsidy to operator(s) – The Client will provide to the operator as per the schedule provided below: -

- i. Immediately on entering into the contract and deposit of security deposit along with a bank guarantee from a scheduled commercial bank in India, in favour of NKGSCCL equivalent to 10% of the total quoted amount of subsidy from the client for 250 vehicle units operated over 5 (years). 10% of the total amount quoted for 250 vehicle units shall be released towards mobilization advance. This

bank guarantee should be valid for a period of six months more than the total project period.

- ii. Upon Deployment of vehicle units on Site in New Town Kolkata 30% of the amount quoted in the financial proposal shall be released for the number of vehicle units deployed in service.
- iii. At the end of 1st year from the date of deployment, 14% of the amount quoted in the financial proposal, per operating vehicle unit, operating for a period of one year on that date..
- iv. At the end of 2nd year from the date of deployment, 14% of the amount quoted in the financial proposal, per operating vehicle unit, operating for a period of two years on that date.
- v. At the end of 3rd year from the date of deployment, 14% of the amount quoted in the financial proposal, per operating vehicle unit operating for a period of three years on that date.
- vi. At the end of 4th year from the date of deployment, 14% of the amount quoted in the financial proposal, per operating vehicle unit operating for a period of four years on that date.
- vii. At the end of 5th year from the date of deployment, 14% of the amount quoted in the financial proposal, per operating vehicle unit operating for a period of five years

This support shall be available to the operator for the number of vehicle units deployed and operating.

The mobilization advance of 10% will be recovered on successful completion of the operations with a simple interest for 5 years at the rate of interest equal to State Bank of India PLR prevailing at that point.

G. Currency of Payment

All payments by the client and users of the system under the contract shall be made in Indian Rupees only.

H. Infrastructure Support

The client shall provide infrastructure support by providing space and super structure for Bike Stations where at least 10 bicycle docking points are to be set up by the operating agency with overall structure construction of the bike stations constructed by NKGSCCL wherein the docking arrangements are to be installed by the operating agency..

- i. The indicative location of the bicycle docking stations with their coordinates is provided at Annexure 10
- ii. The docking stations will be constructed by NKGSCCL the internal docking structure controlled by the central smart

phone application will have to be installed by the operating agency.

- iii. The expectation of the client as to the specifications and features of the system is provided at Annexure 1
- iv. Open space to the extent of more or less 400 square meter will be provided on rent for the project tenure by NKGSCCL to set up workshop shed.
- v. The space for setting up the control centre will be provided by NKGSCCL on rent. The rent will be determined on the basis of Land Acquisition rate

I. Earnest Money Deposit/Bid Security

Intending bidder may download the tender documents from the website <http://wbtenders.gov.in>. All the bidders will have to submit On-line Earnest Money of amounting of Rs 2 lakhs & necessary Earnest Money will be deposited by the bidder through the following payment mode as per Finance Department Order No. 3975-F(Y) dated 28th July, 2016 .

- i. Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI bank payment gateway.
- ii. RTGS / NEFT through bank account in any bank. The EMD shall be deposited in favour of "New Town Kolkata Green Smart City Corporation Ltd" payable at "Kolkata"

No interest shall be payable by the Client for the sum deposited as EMD.

Unless forfeited in accordance with Clause J below, the EMD of the unsuccessful Bidders will be returned within 1 month of signing of the Contract with the successful Bidder. The EMD of the successful Bidder will be returned upon the selected Bidder furnishing the Performance Security in accordance with Section 5, C.

J. Forfeiture of EMD

The EMD shall be forfeited and appropriated by the Client as mutually agreed genuine pre-estimated compensation and damages payable to the Client for the time, cost and effort to the Client, without prejudice to any other right or remedy that may be available to the Client under the RFP or in law under the following conditions:

If a Bidder withdraws or modifies their Proposal during the Proposal validity period or any extension agreed by the Bidder thereof.

If a Bidder is disqualified;

If a Bidder is declared the first ranking Bidder and it:

- i. Withdraws its Proposal during negotiations. However, failure to arrive at a consensus between the Client and the first ranked Bidder shall not be construed as withdrawal of proposal by the first ranked Bidder; fails to furnish the Performance Security in

accordance with Section 5,C of the RFP;

- ii. fails to sign and return, as acknowledgement, the duplicate copy of the letter of award;
- iii. fails to fulfil any other condition precedent to the execution of the Contract, as specified in the letter of award; or
- iv. Fails to execute the Contract

Submission, Opening and Evaluation

A. Submission of Proposals

- a. The Proposal shall be submitted in electronic form at the e-tender site wbtenders.gov.in
- b. The Client will not be responsible for any delays, loss or non- receipt of Proposals. Proposals submitted by fax, telegram or e-mail shall be rejected.
- c. Following schedule shall be adhered for the bid process

- d. The Applicant shall be selected under the Quality cum Cost Based System QCBS) with 60 marks being the qualifying marks for being eligible for opening of financial bids.
- e. The Financial offer of only the bidders who qualify with 60 points in technical score will be opened for evaluation.

- f. The qualified bidder quoting least amount of financial support from NKGSCCL for each vehicle unit will be the selected bidder subject to compliance with all other relevant terms and conditions.
- g. Any bid received by the Client after the bid submission deadline prescribed by the Client in the RFP, will be rejected and returned unopened to the Bidder.
- h. The Client may, at its discretion, extend this deadline for submission of bids by amending the RFP, in which case all rights and obligations of the Client and Bidders will thereafter be subject to the deadline as extended.

B. Withdrawal, Substitution and Modification of Bids

- a. The Bidder may withdraw, substitute, or modify its bid after submission, but prior to Proposal due date.
- b. Bids requested to be withdrawn shall not be opened.
- c. No bid may be withdrawn, substituted, or modified in the interval between the bid submission deadline and the expiration of the bid validity period specified by the Bidder in the Bid Submission Form, or any extension thereof agreed to by the Bidder. Withdrawal of a bid during this interval may result in the forfeiture of the EMD/Bid Security, if any, pursuant to RFP.

C. Performance Security

- a. Upon selection, the Bidder shall furnish to the Client, a performance security of the amount specified in Clause 16.2 below, on or before execution of the Contract to secure the due performance of the obligations of the Bidder under the Contract (the **Performance Security**). The Performance Security will be in the form of a Demand Draft payable at Kolkata issued in favour of **New Town Kolkata Green Smart City Limited**.
- b. The Performance Security shall be for an amount equal to 10% of the total value of financial support, payable for deployment of at least 250 Vehicle Units.
- c. The Performance Guarantee shall remain valid during the concurrency of the contract and at least an year beyond the contract period.

D. Insurance

The operator/ agency would be required to maintain at their own cost, insurances as may be required for bicycles and allied infrastructure deployed as part of this RFP along with third party liabilities that may arise during the performance of the services forming part of this RFP.

E. Evaluation of Qualification and Technical Proposal

- a. The evaluation of qualification proposal will be undertaken as per minimum eligibility criteria provided below:

Negotiations and Award

A. Negotiations

- a. The qualified bidder quoting the least amount of financial support from NKGSCCL will be considered the successful bidder and invited for contract signing. The successful bidder may, if necessary, be invited for negotiations with the Client. The negotiations will be held at the date and address as informed by the Client.
- b. The Client shall prepare minutes of negotiations which will be signed by the Client and the Bidder's authorized representative.
- c. If the negotiations fail, the Client shall inform the qualified least quote Bidder in writing of all pending issues and disagreements and provide a final opportunity to them to respond. If disagreement persists, the Client shall terminate the negotiations informing the least quote Bidder of the reasons for doing so. Upon termination of the negotiations with the first/highest ranking Bidder, the Client may invite the next least cost Bidder to negotiate the Contract with the Client or annul the bid process, reject all Proposals and invite fresh Proposals. If the Client commences negotiations with the next-ranked Bidder, the Client shall not reopen the earlier negotiations.

B. Award of Contract

- a. The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the selection process. Notwithstanding anything to the contrary contained in this RFP, the Client shall reject a Proposal without being liable in any manner whatsoever to the Bidder, if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices") in the selection process. In such an event, the Client shall, without prejudice to its any other rights or remedies, forfeit and appropriate the Performance Security, if available, as mutually agreed genuine pre-estimated compensation and damages payable to the Client for, inter alia, time, cost and effort of the Client, in regard to the RFP, including consideration and evaluation of such Bidder's Proposal.
- b. Without prejudice to the rights of the Client under Clause a. Herein above and the rights and remedies which the Client may have under the LOA or the Contract, if a Bidder is found by the Client to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the selection process, or after the issue of the LOA or the execution of the Contract, such Bidder shall not be eligible to participate in any tender or RFP issued by the Client during a period of 2 (two) years from the date such Bidder is found by the Client to have directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case maybe.
- c. For the purposes of this Clause c, the following terms shall have the meaning hereinafter respectively assigned to them

C. Corrupt and fraudulent practices

- a. "corrupt practice" means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of any person connected with the selection process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of the Client who is or has been associated in any manner, directly or indirectly with the selection process or the LOA or has dealt with matters concerning the Contract or arising there from, before or after the execution thereof, at any time prior to the expiry of 1 year from the date such official resigns or retires from or otherwise ceases to be in the service of the Client, shall be deemed to constitute influencing the actions of a person connected with the selection process; or ii) save as provided herein, engaging in any manner whatsoever, whether during the selection process or after the issuance of the LOA or after the execution of the Contract, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Contract, who at any time has been or is a legal, financial or technical Consultant/adviser of the Client in relation to any matter concerning the Contract;
- b. "fraudulent practice" means a misrepresentation or omission of facts or disclosure of incomplete facts, in order to influence the selection process;
- c. "coercive practice" means impairing or harming or threatening to impair or harm, directly or indirectly, any persons or property to influence any person's participation or action in the selection process;
- d. "collusive practices" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party ;
- e. "undesirable practice" means (i) establishing contact with any person connected with or employed or engaged by the Client with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the selection process; or (ii) having a conflict of interest; and
- f. "Restrictive practice" means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the selection process.

D. Dispute Resolution Mechanism

- a. All disputes or differences arising out of or in connection with this contract, can be raised before the Chief Executive Officer- NKGSCCL in writing giving full description and grounds of Dispute.
- b. It is clarified that merely recording protest while accepting measurement and/or payment shall not be taken as raising a dispute.
- c. No issue of dispute can be raised after 45 (forty five) days of its occurrence. Any dispute raised after expiry of 45 (forty five) days of its first occurrence shall not be entertained and the

NKGSCCL shall not be liable for claims arising out of such disputes.

- d. Competent Authority shall decide the matter within 45 (forty five) days of notice of such disputes.
- e. Appeal against the order of the Competent Authority can be preferred within 30 (thirty) days to the Appellate Authority (Chairman, NKGSCCL) .
- f. The Appellate Authority shall decide the dispute within a further period of 45 (forty five) days.
- g. If the dispute is not resolved at the level of the appellate authority, then the dispute may be processed through arbitration in accordance with the provisions of Arbitration and Conciliation Act 1996.
- h. The Contractor shall have to continue execution of the Works with due diligence not withstanding pendency of a dispute before any authority or forum.
- i. Only the courts in Kolkata shall have jurisdiction to try all disputes and matters arising out of any contract/agreement under this RFP.

ANNEXURE I: TECHNICAL REQUIREMENTS

1. Project Deployment

- a. The Agency would be required to deploy the PBS system within 3 months from the issue of work order. The payment of financial support (Section 4,F) for deployment of VUs shall be based on the number of VUs deployed by the Agency. The operation stage shall be for a period of 5 years from the date of entering into contract with the NKGSCCL. The payment of first 30% of support amount will be on the basis of bi cycles deployed and operational with at least the indicative 20 docking stations. The 14% yearly payment will be on the basis of number of VUs operational at the end of the operational year when the amount is paid out. VUs deployed after the commencement date and during the contract period will be entitled to proportionate last instalment.
- b. It may be clearly understood here that such payment will be available only if the VUs, docking stations and mobile based app is operating to the satisfaction of the NKGSCCL. Each VU vehicle shall be numbered with unique identification number and should be identified in the dash board and the app with that unique identifier only so that operation and /or availability of each bi cycle and e bi-cycle is traceable through the app, to NKGSCCL.
- c. The 14% annual payment shall be available for those VUs which have completed one year of operation.
- d. Illustrative example: Say on August 5, 2019 a batch of 100VUs are deployed with 20 operating docking stations. NKGSCCL will monitor such deployment, through the IT system as well as through physical inspection. In August 2019, the operator will be eligible for the first 30% support for 100 VUs in August 2019. In November 2019 another 100VUs are deployed with 10 docking stations operational. As the 20 stations are not operational, these 100VUs will not be eligible for the deployment grant of 30%. Instead, the agency will have to pay penal charges for non-operation of the 10 docking stations. Now, in December 2019, all 20 docking stations become operational. So in December 2019, the 100VUs deployed in November 2019 will become eligible for the 30%

deployment grant. In August 2020 the first batch of 100VUs will become eligible for the second instalment of 14%, provided the service level is maintained throughout the year. The other batch will become eligible for the next 14% of financial support in December 2020 provided the Service level is maintained throughout the year, to the satisfaction of NKGSCCL.

2. Bicycles:

Agency may adopt following indicative specifications for New Town Kolkata Public Bicycle Sharing System and is encouraged to provide better designs that are aligned to the objectives of the project and is further encouraged to keep improving the features during the contract period:

2.1 Standard Bicycle:

The Standard Bicycles shall have unique design and be easy to differentiate from general cycles available in the market. The bicycles deployed should be new and not have been used during last one month prior to deployment in the public sharing system. All the bicycle should have following minimum, but not limited to, specifications as necessary component:

Standard battery operated bi cycle:

- Battery operated only or battery and pedal operated
- Maximum speed of 25 KMPH
- Fitted with 250 watt battery operated electric motor

- d. Rechargeable Li ion battery of 36 volt
- e. Fitted with e brake system to immobilize the motor on application of brakes
- f. Sturdy and easy to handle design
- g. Fitted with app driven locking compatible with docking system
- h. Fitted with well-equipped GPS based tracking system

Provided that all battery operated or battery assisted Bi-cycles/ E-Bikes should be compliant with the Central Motor Vehicles (5th Amendment) Rules 2014 notified vide gazette notification No.221 dated April 24, 2014 of the Ministry of Road Transport and Highways , Government of India.

Specification of Mobile App:

- i. Mobile App to be provided for booking, closing of any trip.
- j. Cycle locks should be operated by the app only so that it can be unlocked by an authorised user only.
- k. App should be in compatible with android and iOS. Users can download the App from Google Store or Apple Store.
- l. Platform independent Smart Phone apps capable of operation and being supported in Android, iOS and Windows operating system.
- m. Should be able to provide information about the system- static and real time for the ease of the user
- n. Should be linked to Google maps
- o. Should have the feature of registration of users with OTP, Receiving payment through multiple options of online payment in a secured manner, Tracking bicycles and e bicycles, unlocking the VUs, locking bicycles and e bicycles , throwing alarm on removal of tracker from bicycle and e bicycle , Managing geo fencing with immobilization on expiry of subscription or moving out of the operational area, providing location based availability information to the user including probable time of being available next.
- p. Should be enabled to integrate information on a later date, if required by NKGSCCL

Monitoring Dashboard:

- a. Client should provide an administrative dashboard to monitor locations and movement of the all cycles.
- b. MIS to be provided for Daily and Monthly trip details, Availability of Cycles, Locations with cycle details at any date and time.
- c. Dashboard should be mobile compatible.
- d. Alert System (a) in case cycle placed into an unwanted location for a stipulated time,(b) Area Violation, (b) Maintenance work

Others Terms and Conditions:

- a. Client should provide open API to integrate with proposed one city app to facilitate booking through the one city app.

- b. Open API to be provided to integrate with proposed Command and Control Centre for integration with administrative dashboard and monitoring in real time.
- c. The system should be on open sources so that it can be integrated with any third party application.
- d. System should support the following standards such as Web sockets, REST APIs and typical formats like HTML, JSON etc to have integration with Smart City digital Platform.

3. Docking stations

Docking stations will be built by NKGSCCL at sites mutually decided with at least 20 sites to start with. The indicative position map of these sites and a list of these 20 sites is provided at annexure 10 and annexure 11 of this RFP document respectively. The docking arrangement will have to be installed at the docking stations by the agency.

4. RevenueRights:

Agency:

The Agency shall have rights to generate revenue from following sources during the contract period:

- a. Memberships: Sale of memberships and subscription to use the PBS system.
- b. Fare box revenue: Charges earned from the use of the PBS system by users having no membership.
- c. Cycling Event(s): The Agency shall be given the permission to conduct cycling event(s) in the city, and generate revenue from such events. Any cost related to conceptualization, organization and marketing of such events shall be borne by the Agency.
- d. System Branding: The agency may desire to brand their public bicycle sharing system through sponsorship funding. All such rights for system branding and realization of related revenue shall rest with the Agency.
- e. Sponsorships / CSR Funding – The operator / agency will be permitted to receive sponsorships and CSR funding for their system.

Client (i.e. NKGSCCL):

The client shall retain the rights to generate revenue from following sources during the contract period:

- (a) Advertisements: Through placement of advertisement at the advertisement panels to be installed at the docking/standing locations or otherwise.
- (b) By setting up take away snacks bar at docking stations wherever possible.

5. PBS System Charges:

Security Deposit:

- a. The Agency shall be permitted to receive a refundable security deposit as a security fee which can be charged from users to ensure safe usage of the infrastructure provided to them.
- b. The amount of security deposit should not be unjustified and the client shall retain the right to direct the Agency to modify security deposit charges in such case.
- c. The amount of security deposit shall be same, irrespective of users and their membership pattern.
- d. The Agency shall be responsible for refunding all the deposit, in case no damage is created by the user to the bicycles or other components of PBS system, at the end of membership term unless the user renews his/her membership for another year.

User Fee /Subscription Fee/ Membership Fee:

The Agency shall collect a User Fee or subscription / Membership fee from all the users who want to become a member for using the system.

Not all users who are registered with the system are required to become members.

Only members shall be given the rights to use the system unlimited times.

The Agency shall offer different membership options to the system users, such as yearly membership pass (valid for a year), quarterly membership (valid for three months), monthly membership pass (valid for months) or one time user.

Although the final structure of membership fee shall be decided after mutual agreement between Client and Contractor.

User Fee:

The Contractor shall levy and collect fee from all the users based on the amount of time for which the bicycles are borrowed.

The final fee structure shall be as decided in mutual agreement between Client and the Contractor.

Processing Fee:

The Agency will be permitted to charge an amount, to be decided & approved by authority, as processing fee for registration of a non-member in the system.

All the members will be exempted from this charge.

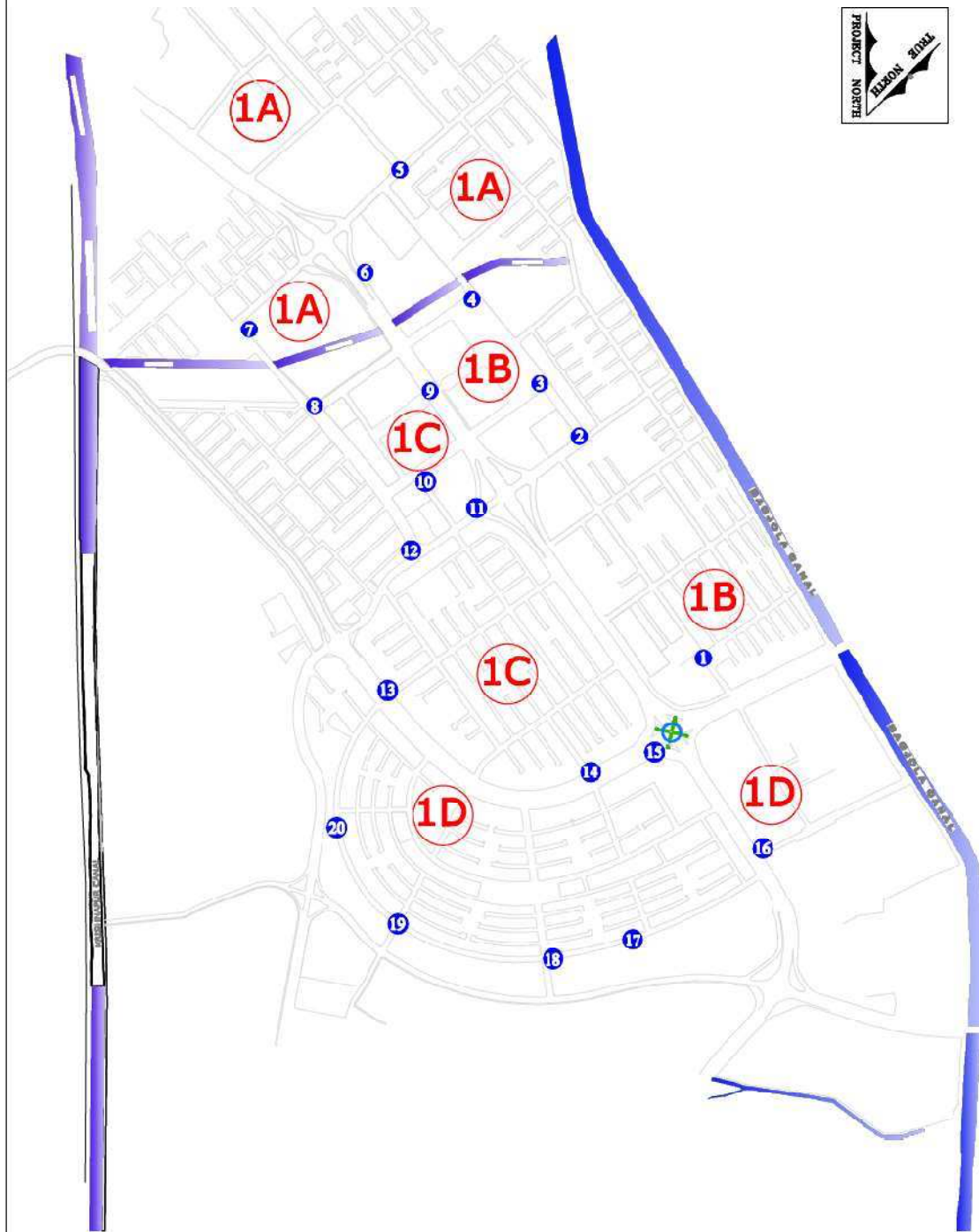
