Earnest money of the L2 bidder is to be refunded after the Work order is issued in favour of Ll bidder.
 - E.M.D. of the L1 bidder for tenders of State Government offices will automatically get transferred from the pooling account to the State Government deposit head "8443-00-103-001-07" through GRIPS along with the bank particulars of the L1 bidder.

The tenderer whose tender is approved for acceptance shall within 7 days of receipt of Acceptance Cum Work Order make an agreement with the tender accepting authority with due deposit of an additional amount together with the already deposited Earnest Money so as to make 2% of the tendered amount of the work. Failing such deposit of this additional amount, within the period specified above, the Earnest Money already deposited shall forthwith stand forfeited to the authority.

- 13. Additional Performance Security:- If the accepted rate is 80% or less than the estimated value of the work, the successful bidder shall have to submit Additional performance security @10% of the tendered amount in form of Bank Guarantee from any scheduled Bank within 7 days from the date of issue of Acceptane order, failing of which his Earnest Money will be forfeited and other necessary action like black listing of the agency etc. shall be taken. The Bank Guarantee shall have to be valid up to the end of contract period and shall have to be renewed accordingly, if required.
- 14. Defect Liability Period:

Original work:- 06(six) month from the date of completion of Trial Run.

O & M works: 03 (Three) months from completion of each years of O & M.

Security Deposit:- Security Deposit:- the earnest Money Deposit of the successful bidder will be converted to security Deposit Balance amount of security deposit @ 8% (Eight percent) will be deducted from each and every progressive bill to make 10% security deposit as per terms of the contract.

Refund of Security Deposit:-

- **Original Works:**-After 06(six) months from date of completion of Trial Run proportionate share of security deposit with proportionate share of Additional performance security(if any) subjected to realization of defect liability(if any).
- **O & M works:**-After 03(three) months from date of completion of each year of O & M, proportionate share of security deposit with proportionate share of Additional performance security(if any) subjected to realization of defect liability(if any).
- **15.** No **conditional/ incomplete tender** will be accepted under any circumstances.
- **16.** During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other papers submitted are found incorrect / manufactured / fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
- 17. Before issuance of the work order, the tender inviting authority shall verify the credential & other documents of the lowest tenderer. After verification, if it is found that such documents submitted by the lowest tenderer is either manufactured or false in that case, work order will not be issued in favour of the tenderer under any circumstances. In such case 2nd lowest bidder may be invited for the work.
- 18. Any adverse measure on any account against the agency, who is working at present or worked during last five years, as on the date of bid, under any Govt. dept. and / or recovery outstanding debarred / black listed in any Govt. dept. will lead to rejection of its application for issuance of tender document, even after fulfillment of other eligible criteria, A declaration to that effect will have to be submitted in the form of affidavit in non-judicial stamp paper duly notarized.
- 19. The relevant legible photocopies of document in support of claim to have the desired qualifying criteria as stated above duly attested / authenticated by 1st class Magistrate / Notary Public should be submitted along with the application (Both on-line and off-line).

20. NOTE FOR Eligibility Criteria:

- i) The total value of similar nature of works physically completed (as mentioned in Clause 4) and payment received within qualifying period i.e., the last 5 (five) financial years and current financial year (even though the work might have commenced before the qualifying period) shall only be considered in evaluating the eligibility criteria.
- ii) Tender stipulation (% above / below) of works will not be considered for calculation of work value for determination of eligibility criteria (clause -4b).
- iii) Tenderer has to produce duly attested supporting documents/certificates from the employer / client with whom they have worked, audited balance sheet duly certified by the chartered Accountant and valid payment certificate issued by Govt. Organization / PSU/ Semi Government Organization along with the application (Both on-line and off-line).
- iv) Certificates from the private individual and organization for whom such work are executed shall not be accepted.
- v) The eligible period mentioned above shall be reckoned upto the date of opening of Tender as originally advertised. The extended date of opening of the tender, if any, shall not be taken into account for the purpose of counting eligibility period.

- 21. Tender applications received without the specified certificates and documents shall be rejected.
- 22. The tender inviting authority reserves the right to relax eligibility criteria if felt necessary for the interest of Govt. work.
- 23. Employer / Client's certificates/ Credentials shall be accepted by the Tender inviting authority when the same are signed by an official of the rank not below the rank of Executive Engineer or equivalent in respect of a Govt. / Semi Govt. organization or a PSU and they should be supported by adequate proof of payments received by the contractor for the work done by them.
- 24. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The department reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any reimbursement of any cost that might have been incurred by any Tenderer at any stage of Bidding.
- 25. If any information / document furnished by the applicant (tenderer) is found incorrect even at a later stage, he shall be liable to be debarred from tendering / taking up work in any Department under Govt. of West Bengal including imposition of other legal measure(s) as per law of land.
- **26.** For further detailed information, the intending applicant shall have to contact the office of the Executive Engineer, N.T.K. W/S Divn-II, PHED on any working day during office hours.
- 27. Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the tenderers who resort to canvassing will be liable to rejection.
- 28. The rates quoted in the Tender shall remain valid for acceptance within 120 days from the date of opening of the Tender and should be inclusive of all the taxes duties & cess as applicable.
- **29.** All Corrigenda, Addenda to the original N.I.e.T. and minutes of pre-tender meeting are to be considered as part of the Tender Document.
- **30.** The Contractor will remain liable for following with West Bengal Contract Labour (Regulation & Abolition) Rules in force & necessary. Certificates from appropriate authority to be submitted within 7 (Seven) days from the date of the work order.
- **31.** Mobilization advance, time / cost over-run and consequent cost escalation for any material, labour etc. will not be allowed.
- 32. All materials are to be procured and supplied at site of work by the tenderer / firm at his / their own cost from approved reputed dealer / manufacturer. Only DI (K7 & K9) pipes with Rubber Gasket shall be issued from the Department. No other Departmental materials will be issued.
- 33. On-going payments for work may be allowed to the executing agency as per existing rules and availability of fund. Subject to deduction of security deposit, progressive payment may be made against the completed or partly completed item of works. Such interim payments, shall be made as running account bill (s), however, shall not construed to mean that the respective items / components have finally been approved and accepted by the department and the contractor shall not be absolved of his responsibility to set right any deficiency of such paid items / components at his/ their own cost, for rectifying all defects which are subsequently being

noted or found.

- **34**. No claim for interest or compensation will be entertained in respect to any money or balance of payment which may be due or alleged to be due by the contractor owing to any dispute between the contractor and the department.
- 35. Payment for the supply / work will be made subject to availability of Fund and no interest/ claim will be paid for delayed payment and delay in payment due to some unforeseen reason cannot be ruled out.
- 36. No. price preference and other concession will be allowed as per order no 8648 F(T) dated 12.10.2012.
- 37. Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
- **38.** If any discrepancy arises between two similar clauses on different notification, the clause superseding others will be solely as per the discretion of the Tender inviting authority.
- **39.** Agencies are required to give a work programme preferably in the form of a bar-chart and to approve it by the EIC (Engineer–in-Charge) before commencement of work and if progress of work abruptly differs from the given work program, the undersigned may terminate the work order at any point of time.
- **40.** Arbitration clause should follow the provisions as stipulated in Notification no. 8182-F(Y) of Finance Department, Audit Branch. Notwithstanding whatever has the object of deletion of the said clause from the Contract Form of WBF-2912, the parties entering into the agreement pertaining to this NIeT, if so desire, may go for money suit for any dispute in his / there opinion arising out of this contract and he/ they may file such suit in any court of law situated in Kolkata proper in the district of West Bengal.
- 41. Before submission of any Tender, Tenderer are to visit the sites and satisfy themselves about the local conditions and also other matters that may be raised in relation to the work. Any Tenderer who submitted Tender should be presumed to have done so. Tenderer may see and understand the nature and feature of site and make them acquainted with local conditions and constraints and quote rate accordingly. The Tenderer shall also be presumed to have carefully examined Drawings, General Conditions, Technical Specifications, IS Specifications, Clauses and Sub-Clauses of WB Form 2912, BOQ, General Terms and Conditions, Special Terms and Conditions etc. (if any) and to have fully acquainted with all details of site location, work front, communications, underground utility services, materials, labours, water supply position, electricity and any other general information pertaining to and needed for the work to be completed within stipulated period.
- **42.** The Contractors are bound by the terms and conditions of W.B.F No. 2912 with relevant changes.

43. Qualification Criteria

Qualification Criteria:-

The Tender Inviting & Accepting Authority through an 'Evaluation Committee' may determine the eligibility of each bidder.

The eligibility of a bidder will be ascertained on the basis of uploaded certificates / credentials using digital signature in support of the minimum criteria as mentioned in clause-4and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder/ tenderer will be out rightly rejected at any stage without any prejudice.

If any tenderer withdraws his offer before acceptance or refuse to work within a reasonable time without

giving any satisfactory explanation for such withdrawal, he shall be disqualified for submitting tender to the department for a period as may be decided by the Tender inviting authority.

44. The contractor shall make all safety arrangements required for labour engaged by him at his cost.

SECTION - A

1. General guidance for e-Tendering

Instructions/ Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering. For any support Help Desk is available on the P.H.E.D Office 7th Floor N. S. Building Kolkata-1(Helpline No: 033-65229039) during office hrs on working days.

2. Registration of Contractor

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to http://etender.wb.nic.in (Link is also available in the PHE website i.e. www.wbphed.gov.in). The contractor is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC)

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2. DSC is given as a USB e-Token.

4. The contractor can search & download NIT & Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

5. Submission of Tenders.

General process of submission:

The financial proposal should contain the following document in one cover (folder) i.e. Bill of quantities (BOQ) the contractor is to quote the rate online through computer in the space marked for quoting rate in the BOQ.

Only downloaded copies of the above documents are to be uploaded virus scanned & Digitally Signed by the contractor.

6. Opening & evaluation of tender:-

6.1. Opening of Technical proposal:-

- i. Technical proposals will be opened by the Superintending Engineer as well as Executive Engineer, New Town Kolkata W/S Divn.-II, PHE Directorate or his authorized representative electronically from the web site stated using their Digital Signature Certificate.
- ii. Intending tenderers may remain present if they so desire.
- iii. Cover (folder) statutory documents should be opened first & if found in order, cover (Folder) for non statutory documents will be opened. If there is any deficiency in the statutory documents the tender will summarily be rejected.

6.2. Uploading of summary list of technically qualified tenderers:

- i. Pursuant to scrutiny of Technical Proposals the summary list of eligible tenderers will be uploaded in the web portals.
- ii. While evaluation, the Tender Inviting Authority may summon the tenderers & seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

6.3. Financial proposal

- i. Financial proposals of the tenderers declared technically eligible by the Tender Evaluation Committee will be opened electronically from the web portal stated in the prescribed date, by the Executive Engineer, New Town Kolkata W/S Divn.-II, P.H.E. Directorate.
- ii. The encrypted copies will be decrypted and the rates will be read out to the contractors remaining present at that time.
- iii. However, if there is any scope for lowering down of rates in the opinion of the Superintending Engineer, further negotiation meeting with the lowest bidder may be held at the office of the concerned Executive Engineer which will be done offline. The final negotiation statement shall be uploaded in the website in due course.

7. Tender Selection committee (TSC):-

Existing 'Tender Selection committee' of the P.H.E. Directorate will continue to function as usual in terms of existing Govt. Order. It will be the final authority for acceptance of tender.

8. Penalty for suppression / distortion of facts:
