HIRING OF AGENCY FOR ENCOURAGING THE USE OF CONTACTLESS MEANS OFPAYMENT IN NEW TOWN KOLKATA

Notice Inviting e-Tender No:06/CTO/NKGSCCL of 2020-21

A. BACKGROUND

New Town Kolkata is a planned newly developed greenfield satellite city on the north-eastern fringes of Kolkata in the district of North 24 Parganas in West Bengal. The city has a coverage area of 30 km2 and with a planned population of 10,00,000.

Being a planned and "green" city, the existing settlements have been kept undisturbed and suitably integrated into the proposed land use as wet lands and low lying areas have been designated as open spaces. One of the key USPs towards the development is the flexible planning approach. New Town has been developed in three planning units for phased

Implementation of the plan, referred to as Action Area-I, II, III. There are three action areas where the development is planned. Additionally there is designated Central Business District (CBD). Main administrative and commercial functions have been placed at CBD located at the centre of the city.

The land use breakup of the whole New Town Planning Area shows that residential area covers maximum 40.17% followed by commercial area of 10.14%. IT and ITES has been allotted 4.73%. Social infrastructure areas have been allocated 10.07% and open spaces 14.06%. Commercial, IT and ITES land use has been placed in the centre of the city around which residential land use is distributed.

The city provides best in class urban infrastructure facility and government service delivery to its citizens while preserving the cultural heritage of West Bengal. Over the last few years, the city has achieved world class basic / core infrastructure facilities.

New Town is a Smart City under the Smart City Mission of Government of India.

B. OBJECTIVE

New Town Kolkata Green Smart City Corporation (NKGSCCL) proposes to hire an agency for conducting awareness amongst small, medium, large merchants, street vendors and Toto/Auto operators regarding the use of contactless means of payment and onboarding them onto the contactless transaction ecosystem. It is proposed that these intervention will be planned over a period of 12 months and may be extended subject to the approval of the competent authority. The agency on-boarded will ensure the presence of adequate supervisory and field team for conducting survey and awareness campaigns.

C. SCOPE OF WORK

Key aspects to be covered within the intervention are given below.

1. Baseline Assessment of the payments ecosystem in New Town

This will involve conducting an exhaustive survey of small, medium, large merchants at the 10 NKDA Markets and 2 Hawkers Market, street vendors, Toto/Auto operators and citizens across the city. The findings from the study will assist in analyzing the degree of contactless transactions in the city at the onset of the project. The baseline assessment will focus on multiple aspects, not limited to the list below:

- a. Usage of cash / bank transfer / UPI / wallets / credit & debit cards etc amongst merchants/ vendors / Toto & Auto operators
- b. Usage of cash / bank transfer / UPI / wallets / credit & debit cards etc amongst citizens visiting the

- c. vendors or using Totos& Autos
- d. Prevalence of key players in the contactless transaction economy of New Town Kolkata
- e. Key impediments to successful transition to a contactless transaction economy

2. Awareness Campaign and Onboarding of merchants, street vendors, Toto / Auto operators and citizens onto the contactless transaction ecosystem

This will involve developing a detailed timeline basedplan and will include ongoing awareness campaigns with small, medium, large merchants at the 10 NKDA Markets and 2 Hawkers Market, street vendors, Toto/Auto operators and citizens across the city, to onboard them onto the contactless transaction ecosystem. This activity will include at least 2 awareness campaigns in each market every month, two promotional events with atleast 5% residing population every month and atleast 2 awareness events with Toto/Auto Operators and atleast 1 event with street vendors every month

3. Mid Term Survey and End Line Survey

This will involve conducting a midterm survey and an end line survey at 6 months and 12 months respectively to assess the success of the awareness campaigns and on-boarding initiative undertaken by the selected agency. The midterm and end line survey will assess the transition of small, medium, large merchants at the 10 NKDA Markets and 2 Hawkers Market, street vendors, Toto/Auto operators and citizens across the city from cash transaction to cashless / contactless transactions, vis-à-vis the parameters assessed in the Baseline Survey

The end line survey will be accompanied by an overall impact assessment report highlighting the successful transition of New Town to the contactless payment ecosystem.

4. Documentation and Project Closure

This will involve documentation of each event / activity. Documentation will include photographs and audio-visuals of each event / campaign conducted.

Project closure will include conducting a one day workshop / event with officials from HIDCO / NKDA, vendors, merchants, citizens etc. wherein the findings of the study will be presented.

E. ELIGIBILITY

- a) The bidder should be a registered Indian Company under "The Company Act, 1956/2013"/ Partnership firm/ Proprietorship firm/LLP/NGO/ Registered Society.
- b) Should have experience in promotion of digital payment / organization of promotional events for digital payments in India during the last five years under a Government Department/PSU/Local Body/Corporate body in any city/town.
 - Credential certificate issued by the Executive Engineer or equivalent or competent authority of a state/central Government, state/ central Government undertaking statutory/ Autonomous bodies constituted under the central/ state statue, will be taken as credential.
 - In case of a corporate client this credential should be issued by a member of the board of directors/partner of the client.
 - iii. In case of a corporate client, copy of a work order /contract document (all pages) along with a final payment certificate from a Chartered Accountant.
- c) Intending Tenderer must be financially sound with a minimum average turnover of Rs.50 Lakh, (Rupees Fifty Lakh only) during the last three financial years (FY 2016-17, 2017-18, 2018-19) and having a trade license, G.S.T Registration certificate and Profession Tax certificate.
- d) PAN Card, Income Tax Return Acknowledgement Receipt for the last 03 (Three) Assessment years, P.T. Deposit Challan for the year 2019-20
- e) Registered Partnership Deed for Partnership Firms only along with Power of Attorney since executed under any Judicial Magistrate/First Class Magistrate is to be submitted. The company shall furnish the Article of Association and Memorandum as on-statutory documents.
- f) Detail Resume of one site manager who will be placed on full time basis for the entire project period in Smart City Office for coordinating and monitoring the operation of the project as well as maintaining liaison with NKGSCCL showing his/her detail qualification and experience. This professional should have M.Com/MBA (finance)/AICWA or any other postgraduate qualification in finance with at least 5 years of experience in promotion/training/implementation of digital payment system. The resume should be signed by the incumbent as well as the signing authority of the bidding agency. This person cannot be replaced during the course of the project without consent of the client.
- g) Joint Venture or consortium is not allowed in this tender.
- h) Three consecutive years' (2016-17, 2017-18, 2018-19) Audited Accounts to be submitted along with Tender documents.

F. EVALUATION METHOD

 The eligibility will be determined fromdocuments submitted by the bidder and the decision of the tender inviting authority will be final in determining the eligibility.

 In the financial bid, the bidder has to quote total fees for the entire project inclusive of all taxes and levies at the appropriate link. Disclosure of financial bid at any other place will disqualify the bid.



 The eligible bidder quoting the least cost will be selected as the agency subject to fulfilment of all other criteria.

- 2. In the event of e-filling, intending bidder should download the tender documents from the website http://wbtenders.gov.in directly with the help of Digital Signature Certificate.
- All the bidder shall have to submit earnest money & necessary earnest money will be deposited by the bidder through the following payment mode as finance dept. order no-3975-F (Y) dated 28th July 2016

 - b) RTGS/NEFT through bank account in any bank. The EMD shall be deposited in favour of "New Town Kolkata Green Smart City Corporation Limited" payable at Kolkata.
- Technical and Financial bids are to be submitted duly digitally signed in the website https://wbtenders.gov.in. The acceptance of bid is not obligatory.

- Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule of this NIeT.
- 7. In term of Finance Department, Audit Branch, Govt. of West Bengal's Notification no.4374-F(Y) dated 13th July, 2017, the bidder has to uploaded valid 15-digit Goods and Service Taxpayer Identification Number (GSTN) under GST Act, 2017, along with his bid. The bidder should note that bid submitted without GSTIN will be summarily rejected
- 8. The Earnest Money Deposit of Rs.1,00,000 (Rupees one lakh Only) will be converted to Security Deposit for the selected agency.



9. Intending Tenderer must be financially sound with a minimum average turnover of Rs.50 lakh (Rupees fifty lakh only) during the last three financial years (FY 2016-17, 2017-18, 2018-19) and having a trade license, G.S.T Registration certificate and Profession Tax certificate.

- 11. Registered Partnership Deed for Partnership Firms only along with Power of Attorney since executed under any Judicial Magistrate/First Class Magistrate is to be submitted. The company shall furnish the Article of Association and Memorandum as on-statutory documents.
- 12. Joint Venture or consortium is not allowed in this tender.
- 13. Sub vendors may be engaged on getting their credentials vetted by NKGSCCL in the post tender phase.
- 14. Three consecutive years' (2016-17, 2017-18, 2018-19) Audited Accounts to be submitted along with Tender documents.
- 15. Fund for this project will be made available from the Smart City Mission by the New Town Kolkata Green Smart City Corporation Limited.
- 16. No claim for interest or compensation will be entertained in respect to any money or balance of payment which may be due or alleged to be due to the agency owing to any dispute between the contractor and NKDA or in respect to any delay in making payment of progressive or final bill of the work, to the contractor.
- 17. No advance and secured advance will be considered.
- 18. Idle labour, idle rent and hire charges etc.: No claim of any category and type, on this ground shall be entertained. The contractor and NKGSCCL shall make every effort that such situation does not arise.
- 19. Security Deposit: Earnest Money for the successful tenderer will be retained and converted to Initial Security
- 20. Income Tax & G.S.T will be deducted as per Govt. orders issued from time to time and would be applicable on the date of making payment of the bills.
- 21. The Bidder, at his own responsibility and risk is encouraged to visit and examine the town and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction. The cost of visiting the site, shall be at his own expenses.
- 22. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. New Town Kolkata Development Authority reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any reimbursement of any cost that might have been incurred by any Tenderer at any stage of Bidding.
- 23. Prospective applicants are advised to note carefully the minimum qualification criteria before tendering the bids.
- 24. Conditional / Incomplete tender will not be accepted under any circumstances.
- 25. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.



26. Before engagement, Tender Inviting Authority may verify the credential and other documents of the qualified tenderer if found necessary. After verification if it is found that the documents submitted by the tenderer is either manufactured or false in that case the said Tenderer will not be empaneled under any circumstances and his/their offer will be treated as cancelled.

27. If any discrepancy arises between two similar clauses on different notification, the clause

superseding others will be solely as per the discretion of the Tender inviting Authority.

28. The successful Tenderer whose tender is accepted shall make formal agreement along with bid documents in triplicate, within 7 (seven) days from the date of issue of work order by Chief Executive Officer, New Town Kolkata Development Authority on payment of usual chargeswhich is non-refundable under any circumstances and submit the same duly signed by him/them to this office. If the contractor fails to perform the formalities within the specified period the Tender is liable to be cancelled and the Earnest Money will be forfeited as per relevant clauses of WBFR.

29. Qualification criteria:

- The tender inviting and Accepting Authority will determine the eligibility of each bidder. The bidders shall have to meet all the minimum criteria as stipulated in relevant clauses of this NIeT.
- The eligibility of a bidder will be ascertained on the basis of the document(s) submitted in ii. support of the minimum criteria. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder / tenderer will be rejected at any stage without any prejudice to take any penal action against him/them as may be deemed fit by the Tender Accepting Authority.
- 30. The agency must have the capacity to engage professionals as directed by the CTO, NKGSCCL.
- 31. Agencies are required to give a work programme preferably in the form of a bar- chart and to get it approved by the CTO, NKGSCCL before commencement of work and if progress of work abruptly differs from such work programme, the undersigned may terminate the work order at any point of time and penal action as per Tender Terms and conditions will be imposed.
- 32. Intending tenderer should note that he may have to work simultaneously with other contractors already entrusted with other work or with contractors to be entrusted with other work in future in the same function. The contractor will have to work in close co-operation and harmony with all the contractors engaged in the project. Any claim for idle labour, for any reason whatsoever, will not be entertained under any circumstances.
- 33. NKGSCCL will not be held responsible for making payment against any anticipated profit and/or compensation for any losses or price escalation whatsoever for the works as stated in the annexure of this NIeT. Rates should be quoted accordingly.
- 34. The address as furnished by the contractor shall be deemed as the postal address of this office. Any notice or instruction to be given to the contractor under the terms of contract shall be deemed to have been served if it has been delivered to his authorized agent (on the strength of authorization) or representative or sent by registered letter to his official address as furnished.
- 35. Arbitration clause of WBF 2911(ii) stands deleted.
- 36. Participation in this tender deems that the applicant is fully agreeable to abide all terms and conditions as stated in this Notice Inviting e tender.
- 37. Mobilization advance, time / cost overrun and consequent cost escalation for any material, labour, etc. will not be allowed.
- 38. The offer shall remain valid for 180 days from the date of opening of the tender.
