Originals will be returned after verification.
2. Valid certificate/ document of FSSAI notification and NABL accreditation should be submitted.
3. New Town Kolkata Green Smart City Ltd shall not be liable for any cost to be incurred towards execution of the work.
4. No application will be entertained if sent by Post/Courier.

5. Quoted rate should be submitted in sealed cover and super scribed with the Name of the Work applied for, with N.I.T No. & Sl. No. and to be submitted in the Tender Box at the concerned office.
6. The rates are to be quoted both in words and figures as per schedule and perusing necessary Terms & Conditions attached herewith. The rate quoted is valid for acceptance up to 6(six) months from the date of opening of the Rates. The rates quoted should be considered as inclusive of sales tax and other taxes and all other charges. No claim for any extra charge what so ever will be entertained.
7. The applicant should sign all corrections in the application with the date. The applicant must sign each page of the application, notice, relevant documents, etc. which forms part and parcel of the application document. The intending participants required to sign in English or Bengali or Hindi. Signature of applicant in all locations must be identical but the rates shall be quoted in English only.
8. The applicant who will sign on the documents on behalf of a company or firm must produce the registered documents in respect of their competency to do so, failing which the application will not be considered.

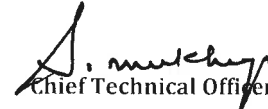
